Only scientific articles which follow the regulations, mentioned in appendix 1, will be accepted for publishing.

Literary sources used in the article, are required with the pages mentioned. References to sources are given in the text in square brackets (for instance [2, p.37], where 2 – is the source according to the list of sources, page 37) in the order in which it was used in the text.

The length of the article has to be from 5 to 8 full pages.

The language of the article is only English.

The pages are not numbered.

The article is printed in MS WORD (7.0 or 8.0) and submitted electronically on a disk and in a hard copy (2 copies) following the requirements and the model with the personal signature of the author.

Paper size is A4, margins are 2 cm. The text is printed in Times New Roman font, size -12 points with spacing -1. The first line of the paragraph is indented 1.27 cm. Tables and pictures are grouped. The formulas are printed in Microsoft Equation 3.0.

The electronic version is saved in *.doc and has the name of the author (authors).

The information about the author is to be sent to the editorial board to ensure the publishing of the article.

Each article will be estimated according to the rating system. In case the article is accepted the author will have to send the payment to the university account.


